## WHO CAN APPLY?

To be eligible, you must:

- Be a Canadian citizen or permanent resident.
- Have graduated from Bill Woodward School in 2020, but not yet commenced post-secondary studies OR be graduating from Bill Woodward School in 2021.
- Submit an online application.
- Be planning to enter full time studies in the first year of a degree, diploma or certificate program, or the first year of apprenticeship technical training (classroom studies) of an eligible apprenticeship program.

NOTE: This scholarship program is administered by Universities Canada. Universities Canada will handle the application process, recipient selection, and payment of scholarships to recipients on behalf of CNOOC International. You must submit your application online to Universities Canada.

## WHAT PROGRAMS DOES THE CNOOC INTERNATIONAL SCHOLARSHIP – BILL WOODWARD SCHOOL SUPPORT?

- There are no restrictions on the area of study or discipline.
- Certificate programs must be of a minimum one-year duration.
- Diploma programs must be of a minimum two-year duration.
- Degree programs must be of a minimum three-year duration.
- University preparatory programs in any jurisdiction are not eligible (e.g. CEGEPs, pre-university diploma).

## ELIGIBLE INSTITUTIONS

- Canadian, American and foreign educational institutions that have recognized degree/diploma-granting powers, or their affiliates (e.g. universities, colleges/CEGEPs - technical diploma). For foreign and private post-secondary institutions, you may be required to provide Universities Canada with documentation proving that the institution is properly accredited and that your program meets the program requirements of this scholarship.
- Alberta Apprenticeship Programs recognized under the Alberta Apprenticeship and Industry Training Act or recognized by any equivalent Canadian or US government agencies.

## WHAT IS THE VALUE OF THE SCHOLARSHIP?

Scholarships will be awarded up to this value over the life of the program.

### DEGREE/DIPLOMA/CERTIFICATE PROGRAMS

- \$2,500 CAD per year towards tuition and other expenses for degrees, diplomas or certificates.
- Available for up to four years for first degree or diploma.
- Available for up to two years for first certificate.

### APPRENTICESHIP TECHNICAL TRAINING

- \$750 CAD towards tuition and other expenses for each period of apprenticeship technical training (classroom studies) available for up to four years or until the apprenticeship program is completed or until the applicant has received a maximum of \$3,000, whichever occurs first.

## WHAT DOCUMENTS DO I NEED TO SUBMIT?

Once students are notified that they are a scholarship recipient, they will need to provide the following in order to receive the award:

- Official high school transcripts.
- Proof of registration from the educational institution they will be attending.

## ARE DEPENDENTS OF CNOOC INTERNATIONAL EMPLOYEES ELIGIBLE TO RECEIVE THIS SCHOLARSHIP?

Students who are dependents of CNOOC International employees are eligible to apply for this scholarship as well as CNOOC International's Scholarship Program for Dependent Children of Employees. However, they are only able to accept one of the two awards.

Universities Canada must receive your application by July 28, 2021 by 1:00 P.M EST. You will be notified in August whether you are awarded a scholarship.
